2. Program overview

Toronto Hydro's Local Demand Response Program ("Program") provides Participants with the opportunity to help support grid reliability and earn incentives by reducing electricity use during periods of high demand.

3. Program eligibility criteria

In order to be deemed eligible to participate in the Program, the applicant must meet the following Program eligibility criteria. Toronto Hydro will review and confirm the applicant's eligibility based on these requirements.

- Participating loads are located in an area served by at least one of the following six target transformer stations (TS):
 - Finch TS
 - Leslie TS
 - Manby TS
 - ° Horner TS
 - Strachan TS
 - ° Dufferin TS
- The total resource capacity is at least 500 kilowatts (kW) (i.e., single facility or aggregated resource)
- Applicable to aggregated DRs only: The aggregated DRs are all located in areas served by the target stations. Capacity may be aggregated by station pair:
 - Manby TS / Horner TS
 - ° Strachan TS / Dufferin TS
 - ° Leslie TS / Finch TS
